

# Ou Personal Loan kapav fer ou al Cape Town



## Conditions de participation :

1. The Mauritius Commercial Bank Limited (hereinafter referred to as "MCB"), whose registered office is at 9-15, Sir William Newton Street, Port Louis, Republic of Mauritius, proposes this promotional offer, (hereinafter referred to as the "Offer") to which the following Terms and Conditions shall apply.
2. The Offer is valid from 02 February 2026 to 02 May 2026 [both dates inclusive] (hereinafter referred to as the "Promotional Period").
3. A lucky draw will be held on 15 May 2026 to determine three (3) winners.
4. The winners will win the following prizes (hereinafter referred to as the "Prize"):
  - First prize: A trip to South Africa, for two persons, including airfare, accommodation, activities and a pocket money of MUR 50,000
  - Second prize: A television set including a soundbar
