

Conditions of participation:

- 1. The Mauritius Commercial Bank Limited (hereinafter referred to as "MCB"), whose registered office is at 9-15, Sir William Newton Street, Port Louis, Republic of Mauritius, proposes this promotional offer, (hereinafter referred to as the "Offer") to which the following Terms and Conditions shall apply.
- 2. The Offer is valid from 16 August to 15 October 2025 [both dates inclusive], (hereinafter referred to as the "Promotional Period").
- 3. A lucky draw will be held on 5 November 2025 to determine one winner.
- 4. The winner will win a trip to Italy, for two persons, including airfare, accommodation, excursions and pocket money of MUR 50,000 (hereinafter referred to as the "Prize").
- 5. The Offer is open only to MCB Visa cardholders Classic, Gold, Platinum and Signature credit cards and prepaid cards residing in Mauritius.
- 6. One (1) entry will be counted in favour of the customer for each payment he/she makes, locally, and/or abroad, by the means mentioned in clause 5, during the Promotional Period only (hereinafter referred to as an "Eligible Payment"). He/She will participate in the lucky draw subject to the criteria set out in these Terms and Conditions.
 - i. The number of transactions made during the Promotional Period will be counted to determine the number of entries obtained by the said customer.
 - ii. Card transactions will be counted at the primary cardholder level. Thus, transactions carried out on secondary card(s), will be cumulated to the transactions made by the primary cardholder, to determine the total number of transactions made.
- 7. The recording of transactions carried out locally or abroad will be done according to the authorisation date of each transaction, that is, the date on which the transaction took place.
- 8. MCB employees, persons under 18 years of age, politically exposed persons, holders of Visa Business debit cards, holders of Visa Business and Corporate credit cards, cardholders with late payments or who are subject to recovery procedures with our litigation department as well as customers whose card account(s) is/are in the "collection" process, are not eligible for the Offer. This non-eligibility criterion applies to primary and secondary cards, cards linked to joint accounts, and cards linked to MCB employee accounts.
- 9. Transactions done at automated teller machines (ATMs), at bank counters (any bank), at financial institutions, in casinos, all forms of betting, as well as payments or transactions in cryptocurrency, will not be considered for this Offer.
- 10. The current or savings account linked to a card must be in good standing and managed appropriately and satisfactorily, at the discretion of MCB. In the event that the account is voluntarily or involuntarily closed, terminated or blocked, for any reason, before, during or after the Promotional Period, MCB reserves the right not to offer the Prize.
- 11. Each customer will be able to consult his/her entry number(s) obtained, by calling 202 6060 or by visiting an MCB branch, as from 5 November 2025.
- 12. The draw to determine the winner will take place at the Mauritius Turf Club under the supervision of the Gambling Regulatory Authority (hereinafter referred to as "GRA"). MCB will subsequently contact the winner by telephone and if unreached, a letter will be sent to the customer's postal address available in MCB's database. In case MCB is unable to contact the winner, his/her lottery number will be published in the press.
- 13. The winner shall select the dates of his/her trip from the available trip dates provided by the supplier, within the period from December 2025 to the end of May 2026. MCB will finalise all travel arrangements for the winner and the accompanying person by the end of November 2025.
