Terms and Conditions

1. Promotional offer

- 1.1. MCB Visa cardholders can benefit from up to 8% off on accommodation with Booking.com.
- 1.2. The discount varies between 4% up to 8% based on the total transaction value of the booking.

2. Promotion duration

2.1. The promotional offer is valid from 1 October 2023 to 31 December 2024.

3. How to benefit from the discount?

- 3.1. Sign up or log in to a registered Booking.com account. You must be logged in to benefit from the discount.
- 3.2. Visit the dedicated page www.booking.com/8visacemea
- 3.3. Click on "Unlock deals" under "Unlock special deals".
- 3.4. Insert the code 'VISABKNG' and click on "Send". The code must be applied at the time the booking is made and cannot be retroactively applied after a booking is confirmed.
- **3.5.** Search for your accommodation and insert your dates.
- **3.6.** Choose an accommodation with an 'Instant Reward' badge and the room type to see the rate and estimated discount value displayed in the 'Price Summary'.
- **3.7.** At checkout, opt for the 'Pay Now' or 'Pay Later' option.
- **3.8.** Use an eligible MCB Visa credit card to pay.
- 3.9. Once your booking is complete, you will get an email confirmation highlighting the discounted amount applied to the cost of your accommodation booking.

4. Eligibility

- **4.1.** Any cardholder who uses the code '**VISABKNG**' and who books an accommodation through the dedicated URL www.booking.com/8visacemea with an MCB Visa credit card during the campaign period can benefit from the discount.
- **4.2.** Customers who select 'Pay at property' will not be eligible for the discount.
- **4.3.** The discount is not applicable for bookings made through the Booking.com app or on the Booking.com website without using the dedicated URL www.booking.com/8visacemea
- **4.4.** The discount is not applicable on cancelled and "no show" bookings.
- 4.5. The discount is not applicable for accommodations that do not accept credit cards. These are accommodations that only accept cash as mode of payment and that do not have an "Instant Reward" badge displayed on their listing.
